## COACHING AGREEMENT

**3. Client Rights and Responsibilities:** The Client has the right to be treated with respect and dignity throughout the support process. The Client is encouraged to be open and honest during sessions and to provide feedback to The Beautiful Mind Coach regarding their support experience. It is the Client's responsibility to attend scheduled sessions and to actively engage in the process to the best of their ability.

**4. Qualifications:** The Beautiful Mind Coach represents that they possess the necessary qualifications, credentials, and licenses required to provide support services in accordance with applicable laws and regulations.
